 Col. 7—Indicate the marital status of each person by the letter "M" for married, "S" for single, "W" for widowed, "D" for divorced, and "R" for remarried.
 Col. 8—Indicate the age of each person in years and months.
 Col. 9—Indicate the date of birth of each person in month and day.
 Col. 10—Indicate the date of arrival in the United States for foreign born persons.
 Col. 11—Indicate the language spoken in the home before coming to the United States.
 Col. 12—Indicate the mother tongue or native language of foreign born persons.
 Col. 13—Indicate the citizenship of each person.
 Col. 14—Indicate the occupation and industry of each person.
 Col. 15—Indicate the code of the occupation and industry.
